What is the overall deductible?	In- <u>Network</u> : Individual \$2,500 / Family \$5,000. Out-of-Network: Individual \$7,000 / Family \$14,000.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u> ?	Yes. <u>Prescription drugs</u> ; plus in- <u>network preventive</u> <u>care</u> are covered before you meet your <u>deductible</u> .
